DAY 1: ARRIVE DETROIT

Enjoy this small city settled by Germans from the Bavarian region. The streets are lined with Bavarian style shops including Bronner's Christmas Wonderland and Frankenmuth Riverplace.

DAY 6: FRANKENMUTH - NIAGARA FALLS

Motorcoach into Ontario, Canada*, and drive east to Niagara Falls, one of the natural wonders of the world. Stop to see the IMAX movie: Niagara: Miracles, Myths & Magic. Later enjoy the unique "Journey Behind the Falls" experience where you descend 125 feet and explore 130-year-old tunnels carved through the bedrock. Later check into your hotel for two nights in Niagara Falls.
